All fees are due and payable prior to filing.

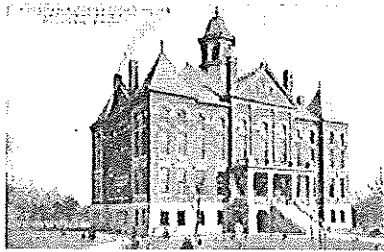
Mortgage Registration Tax is calculated at .05 cents per \$100 dollars of the principal amount of indebtedness. K.S.A. 79-3102.
